

### NCIC holds its Inaugural Symposium on the Place of Faith-Based Leaders and Institutions in Promoting Peace ahead of

s the clock ticks to 2022, NCIC has put together transformative actions to curb identified roadblocks to peaceful elections in Kenya through its Roadmap to a Peaceful 2022 General Elections dubbed 'Elections Bila Noma. On 27th October 2021, NCIC in partnership with the rior, Dr. (Eng) Karanja Kibicho, who was the chief guest Inter-Religious Council of Kenya (IRCK) held its inaugural symposium to affirm the positive role of faith institutions in promoting peaceful co-existence within the election cycle.

Dr. Eng. Karanja Kibicho, PS for State Department for Interior and Co-ordination of National Governent, alongside NCIC Chair, Rev. Dr. Samuel Kobia, amongst other dignitaries addressing members of the press following the Symposium.

The conference, which took place at the Kenya Institute of Curriculum Development (KICD), brought together religious leaders drawn from different walks of faith who not only took part in a candid conversation on how to provide leadership in political dialogue and peaceful processes before, during and after the elections, but committed to

using their structures and functions to talk to politicians and the youth to embrace peace ahead of 2022.

The Principal Secretary for State Department of Inte-(representing Dr. Fred Matiangi, CS Interior) emphasized on the need to have multi- agency collaboration and engagements, including with the clergy, during the elections period. In his media address he averred, "We call upon different players of the criminal justice system to reconcile in order to offer justice to Kenyans and inciters

His words were reiterated by NCIC Chairman Rev. Dr. Samuel Kobia CBS and IRCK Chairperson Rev. Fr. Joseph Mutie, who underscored the need to read from the same script to avoid frustrations when it comes to delivering services to Kenyans.

On her part, the Commission Secretary/CEO Dr. Skitter Ocharo HSC maintained, "we must stress the basic values that are common to all religions: Compassion, Solidarity and Respect

for the human person. It is paramount that Kenyans apply the golden rule of do unto others as you would have them do unto you"





## NCIC meets Speakers ahead of the 2022 Elections


n view of the imminent elections, the Commission desires to put in place several legislative interventions to enhance its performance. Following the enactment of the National Cohesion and Integration (NCI) Act in 2008, the Commission has since identified existing lacuna that calls for review of the said Act.

In view of this, the Commission met Hon. Kenneth Lusaka and Hon. J.B. Muturi, speakers of the Senate and the National Assembly respectively with the aim of discussing the Political Decency and Peace Accountability Charter, as well as strengthening the Commission's performance by amending the existing Act alongside review of the National Cohesion and Peace Building bill. Both legislative proposals are under consideration in

Speaking during the workshop, the Vice Chair reiterated the role of young people in the promotion of democracy, development of talent, peace building and unity, which has a crucial function in nurturing values and cannot be ignored.

Through carefully panned strategies the youth will also aid in promoting oneness, bridge the gap between various political party supporters and act as watchdogs over their communities.

### **NCIC** sensitizing Stakeholders Ahead of 2022

s Kenya counts down to 2022, NCIC advances its mission to deal with the roadblocks to a peaceful General Election through sensitizing various stakeholders. With the Elections Roadmap determined to bring to life transformative action to curb roadblocks to peaceful elections including through empowering citizens to play their optimal role as active agents of peace, NCIC conducted trainings and sensitization forums in Nakuru, Nandi and Uasin Gishu Counties.





In Nakuru County, NCIC trained security actors including Chiefs, Assistant Chiefs, Peace committee members, and Nyumba Kumi officials on hate speech, ethnic-based political violence and peaceful co-existence. Deputy County Commissioner Nakuru Town West, Michael Lesimam said, "we know the source of violence, let us not keep mum as criminal gangs are easily mobilized by politicians and are a threat to peaceful elections". He urged the actors not to lose their patriotism due to political interference.

Following the rising incidences of media misinformation, disinformation, social media incitement and hate speech, NCIC also sensitized journalists, bloggers and reporters of vernacular media stations on fair and conflict-sensitive reporting in Nandi County.

Speaking during the workshop, Commissioner Hon. Eng. Philip Okundi urged the media and online bloggers to take up the role of gatekeeping in the society while reporting fair and balanced news. He urged the journalists to regulate politicians and deny them a platform for incitement to violence, especially as the country gears up to 2022.

His remarks were echoed by the County Commander, Mr. Herman Shamu, who emphasized on the need for a patriotic society and media participation in protecting the country from bad leadership, ethnic contempt and disinformation.

It was observed that there was a gap in media inclusion and participation in peace and cohesion processes. Partners from the Uwiano platform for peace, Communication Authority of Kenya, Office of Registrar of Political Parties, as well as the Media Council of Kenya resolved to increase media participation in spreading awareness and inclusion in conflict solution processes.

Through the signing of a Memorandum of Understanding to stamp their collaboration, the said institutions vowed to implement joint initiatives across the country, for peaceful co-existence. This comes in the wake of NCIC's recently concluded symposium on the role of religious leaders and institutions in promoting peace within the electoral cycle. It is envisaged that these relationships will buttress NCIC's ability to implement its Roadmap towards achieving an Elections Bila Noma.

I like playing basketball.


